

**JUST BETWEEN FRIENDS OF WAUKESHA  
2023 FALL & WINTER SALE  
CONSIGNOR AGREEMENT / WAIVER**

- 1.** I am participating in the 2023 Just Between Friends of Waukesha Fall & Winter Sale as a consignor. **I understand, and agree, that Just Between Friends is not responsible for fire, loss, theft, or damage to my sale items.** I also understand that I earn 60% of my gross sales minus a \$14 consignor fee for my participation.
- 2.** Consignor pick-up (of any unsold, non-donated items) is Sunday, October 22nd from 2-4pm. I understand that any items not picked up during that time will be donated to the charity partners. I will contact Lorraine via email before 8am on pick up day if I change my mind and plan to donate all my unsold items. A \$20 fee will be assessed to all consignor accounts for unsold/nondonated items not picked up by 4pm on Sunday, October 22nd.
- 3.** A “star” (printed on the JBF barcode tags with black or red ink) means an item will remain at FULL PRICE throughout the sale. Tags with no star means the item will be sold at 50% off during the Half Price Sale. For your protection, there will be no alterations (including handwriting) to any tags (lowering/increasing the price or adding or removing a star) allowed at any time during the sale. The barcode tag is the deciding factor for any variation in price/information.
- 4.** I also agree that as a condition of selling items with Just Between Friends, I represent and warrant the following to be true and correct:
  - I am the owner of the items to be sold and I have full authority to sell the items offered by me for sale.
  - Each item offered for sale by me is in good operating condition, reasonable wear and tear expected and it is not defective, broken, or damaged in any way.
  - Any repaired item was repaired by the original manufacturer or in accordance with the original manufacturer’s warranty program.
  - Each item complies with applicable law; <http://www.cpsc.gov/cpsclist.aspx>.
  - No item is subject to any pending or threatened recall or other consumer protection enforcement action.
  - I know of no reason why any item offered for sale by me would cause any injury to another.
  - If more than five items are considered “no thank you” at drop off or pulled from the floor throughout the sale, the consignor will be required to go through inspection during drop off at their next Waukesha JBF sale.
- 5.** I understand that consignor eChecks are sent via email to all sellers within two weeks after the sale ends. All checks must be deposited within 90 days. A \$20 fee will be assessed for eChecks that need to be reissued because they were not deposited within the 90-day period.
- 6.** I understand that at time JBF takes photographs of its events to promote sales and if I do not wish my Image to be used in JBF promotions, I will notify the photographer at the time a picture is taken. Otherwise, I agree to allow my image to be used in JBF sale promotions.
